NOVEMBER 13, 2017

The Vice President elect may be scheduled for duty at the National Training Center in 2018 and he individually or his unit may be assigned to an overseas rotation in 2019.

JROTC Medals: All orders from supplier have been received, providing sufficient quantity for the 2017-2018 school year. The projected expenditure for 2018 budget is expected to be \$8,820.00.

Unfinished Business:
