3. Possibly use a Pay Pal embedded system on the Fort Lowell-Apache Chapter website.
4. Possibly hire a well known and trusted company to be the Fort Lowell-Apache Chapters' electronic presence on the web.

We discussed the ordering history in past 3 years and came to the conclusion that our RTOC Medal operation may not be large enough to justify the monetary cost to conduct the project. CW3R Michael Turner agreed to investigate the 4 points and report back to the Fort Lowell-Apache Chapter.

New Business:

There was a discussion concerning conducting board meetings over the summer, with the outcome agreement that the Fort Lowell-Apache Chapter will not meet for the months of July and August 2018.
